#### MINUTES OF TRUSTEES REGULAR MEETING HELD FEBRUARY 13, 2019 at 7:00 P.M. at the District Office.

**IN ATTENDANCE:** Chair, Roger Mayer, Trustees, Ian Walters, Bill Sparkes & Tim Cottrill; Superintendent, Jo Cottrill and Financial Administrator, Cheryl Halla. Absent from meeting: Trustee, Aaron Beauchamp and Management Consultant, Kevin Huey.

The meeting was called to order by the Chair at 7:03 P.M.

#### MINUTES:

The minutes from the regular meeting of January 9, 2019 were adopted on motion of Bill Sparkes, seconded by Tim Cottrill.

#### **BUSINESS ARISING FROM MINUTES:**

1. Water Project: (7<sup>th</sup> Ave. & Sparkes Drive upgrades) A list of project deficiencies was identified by the Village, the KID, and T.R.U.E. noting that the cost of resolving the deficiencies may come out of the project holdback funds. The final KID portion for the Sparkes Ave. project was proposed by T.R.U. E. / Village to be \$137,981, and after our first progress payment of \$67,230, the amount outstanding would be \$70,751. After discussion, moved by Bill Sparkes, seconded by lan Walters to accept the final cost amount. An invoice will be forthcoming from the Village.

- 2. CIBC Document for Signature: A document required by CIBC was signed by Roger & Ian.
- 3. Budget 2019: Moved to the end of the meeting.
- 4. 2019 Water Restriction Review: See attached proposal: Jo Cottrill presented a proposed revised Water Conservation / Restriction plan. After discussion it was generally agreed by Trustees to proceed and present a new resolution at the next meeting.

After discussion on the possibility of eliminating our separate fax line to save money, it was moved by Bill Sparkes, seconded by Tim Cottrill, to accept the accounts as presented.

- 2. <u>Village of Keremeos- Amendment to Bylaw 807, 2013 & 778, 2011 to prohibit cannabis production</u> KID to respond that our interests are unaffected by the proposed amendment.

#### Subdivisions Cont'd:

3. <u>Village of Keremeos- Subdivision Proposal: Lot 3, Plan 8275, 1116-4<sup>th</sup> St</u>. to create seven lots-After review of the subdivision proposal which will create six additional lots, it was moved by lan Walters, seconded by Tim Cottrill that the following fees and levies will be required on deposit prior to registration of the subdivision:

#### 2019 Budget from above:

After review of the budget proposal, item by item, it was moved by lan Walters, seconded by Tim Cottrill that the tax and toll rates will be increased overall by 3.25%. The tax and toll bylaws will be presented at the next meeting.

# **Proposed Watering Regulations**

### **General Rules for Stages 1 to 3**

- Irrigating is not permitted from October 15<sup>th</sup> to April 15<sup>th</sup>
- Irrigating of crops including vegetable gardens is exempt from stages 1 to 3.
- Hand watering is always permitted.
- Leaving an open free flowing pipe, outlet or hose is never permitted.
- Wasting water is never permitted. (E.g. allowing water from sprinkler to flow down a roadway.)
- Users are encouraged to avoid watering during the hottest periods of the day.
- Automatic sprinkler systems are only permitted to water between midnight and 6 a.m. on days described below.
- The number of manually controlled sprinklers that may operate are restricted based on size of property and are as follows:

025 acres	1 sprinkler	.5175	3 sprinklers
.2650 acres	2 sprinklers	.76 - 1.0	4 sprinklers

# Stage 1 (In affect from April 15<sup>th</sup> to October 15<sup>th</sup>)

- Even number addresses may only water on even numbered days.
- Odd number addresses may only water on odd numbered days.

# Stage 2 (In addition to stage 1)

- Users may not water between the hours of 10 a.m. to 7 p.m.

# Stage 3 (In addition to stages 1 and 2)

- No filling of swimming pools, hot tubs, garden ponds or decretive ponds is permitted.
- No washing of RVs, boats or Vehicles motorized or otherwise is allowed.
- No washing of driveways, sidewalks, Patios or eaves can occur.

### Stage 4

- No outside use of water for any purpose.
